CONTRACT REQUIREMENTS:

- Regular/Junior Club Members – 2 sessions per week (28 weeks at \$24 per week = \$672)
**** 7 monthly payments of \$96 ****
- Bridge/Adult Members – 1 session per week (28 weeks at \$12 per week = \$336)
**** 7 monthly payments of \$48 ****
- Any club member may contract more than 2 sessions per week.
- Ice usage will be recorded weekly. Unused weekly ice **will not** carry over into future weeks.
- Skaters **must** check in with ice monitor before getting on the ice.

PAYMENT REQUIREMENTS:

- All fields of this form must be filled out and contract must be signed or contract will not be accepted.
- BRBFSC reserves the right to cancel any sessions.
- Ice payments (the Balance Due stated above) are divided into 6 equal payments each due the first of every month starting September 1st with the exception of December. Happy Holidays!
- **No contract cancellations or refunds.** Under the terms of this contract you will be financially **responsible** for the full cost of the ice contract for the entire season.
- The Board of Directors of BRBFSC **must approve** any exemptions from the terms of this contract. All requests must be made in writing and presented to the board at a regular monthly meeting of the Board of Directors.
- If the treasurer does not receive payment by the **15th of the month** your account will be considered delinquent and you will be charged a late fee of **\$25**. If your check is **Returned as NSF** you will be charged a fee of **\$35**.
- Delinquent accounts will be considered accounts **“not in good standing”** with BRBFSC and potentially USFS (United States Figure Skating). Accounts **“not in good standing”** will result in **denial of signatures on Test and Competition forms** and may result in **denial of ice time**.
- **ALL ACCOUNTS MUST BE PAID IN FULL BY MARCH 1, 2010.**
